This Warranty remains in effect in perpetuity with the original purchase proof. It covers the lack of conformity of the diamond with the grades stated on this certificate at the time of sale. It does not cover damage to the diamond that occurs after delivery including normal wear & tear, cuts or scratches, consequential or incidental damages provided or allowed by an insurance coverage.
