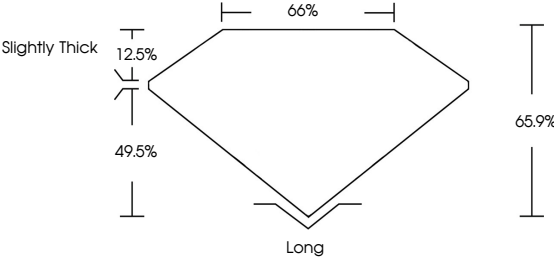

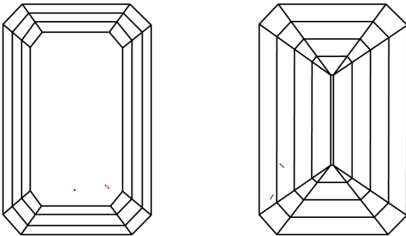

CLARITY CHARACTERISTICS

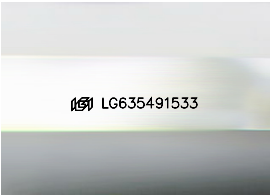

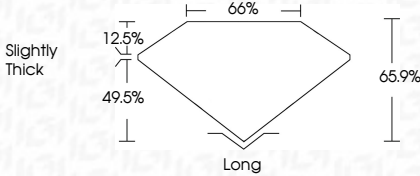
